Madad Welfare Society is a All India Base NGO, working in actively in NCT of Delhi, UP, Rajasthan, Bihar working for the benefit of poor and backward communities in the field to name a few as under:

1. **Child development** – To develop children in all aspects covering health, good quality education and nutrition. We regularly organize medical camps, nutrition building programs and provide education materials, food and clothes to the needy and poor children. We work at grass root level. Children who lost their father or bread earner in the family or whose father is not earning enough to support his family and mother is economically not well in the family, Madad Welfare Society adopts such economically weaker family children.

Madad Welfare Society has spent on the Distribution of food child's contribution as under:

2. **Education** – Provide good quality education for the weaker sections of society who do not have access to even primary education by carrying out workshops and tuition classes for these young students.
